1. This Environmental Decision Statement has been issued on behalf of the Environmental Protection Agency (hereinafter referred to as the Ministry) pursuant to the Environmental Impact Assessment Regulations 2012 (2012/R-27) to advise that the Ministry has decided that the proposed development proposal can proceed according to the Environmental Impact Assessment Report.

- i. In the event the project activity has not commenced within one (1) year from the date of issue, or if the duration of this Environmental Decision Statement has not been extended, this Environmental Decision Statement shall be considered null and void. In order to extend the duration of this Environmental Decision Statement, the Proponent shall write to the Minister for an extension according to clause 14 of the Environmental Impact Assessment Regulation 2012.

- ii. In the event the project activities have been delayed for more than one (1) year due to unforeseen circumstances, the Ministry shall have the discretion to extend the duration of the Environmental Decision Statement, or to terminate it. In such circumstances the proponent shall write to the Minister for an extension clearly





stating out the reasons for the delay.

- iii. The Minister, or his designate, may issue a cessation order requiring persons working on a developmental project to cease working until the order is withdrawn, if:
- This Environmental Decision Statement has been withdrawn or;
 - There has been a breach of the conditions of this Environmental Decision Statement.
- iv. It is the Developer's responsibility to undertake all project activities in accordance with the relevant laws and regulations of the Maldives.
- v. Under the National Environment Protection and Preservation Act (Law no. 4/93) and the Environmental Impact Assessment Regulation 2012, the Ministry reserves the right to terminate any activity without compensation if found that such an activity has caused significant, irreversible





change on the environment.

- vi. All mitigation measures proposed in the EIA report for all the phases of the project shall be fully implemented.

The environmental monitoring program outlined in the Environmental Impact Assessment Report shall be undertaken and implemented and summary environmental monitoring reports shall be submitted to the Ministry. Failure to submit the requisite monitoring report may result in the suspension or revocation of the permit under this Decision Statement.

viii. The date of expiry stated in this Environmental Decision Statement is the duration given to commence the project activities approved under this Environmental Decision Statement.
